DRAFT July 21, 2021 Meeting Minutes

Chairman Hatfield call the meeting to order at 5:31with the following members present: Stacey Graham (Rutland Township), Dave Hatfield (Hastings City), Al Jarvis (Hastings City) and Tom Wiswell (Hastings City).

Members absent: Nicole Haight (Rutland Township) and Robin Hawthorn (Rutland Township)

Others present: Rutland Township Supervisor Larry Watson, JPC Zoning Administrator Les Raymond and Hastings City Manager Gregg Guetschow.

It was moved by Mr. Wiswell and supported by Ms. Graham that the agenda for the meeting be approved as presented. Motion carried.

It was moved by Mr. Wiswell and supported by Mr. Jarvis that the draft minutes of the March 17, 2021 meeting be approved as written. Motion carried.

Chairman Hatfield asked Mr. Raymond to present a report as the Zoning Administrator for the JPC. Mr. Raymond said he had nothing to report. Discussion followed regarding the boundaries of the JPC district and its responsibilities. It was noted that the new Culver's development is in the urban services district falls outside of the JPC area. The need to connect to the City's water system is what determines whether a property in the urban services district falls under JPC control. It was noted that the M-37 Corridor Committee had recommended against granting a driveway permit to Culver's for access onto M-37. Its driveway will connect to Green Street.

Chairman Hatfield asked for a status report the proposed sidewalk on W. State Street. Mr. Guetschow reported that a hearing of necessity for the project was scheduled for the August 9 City Council meeting. Mr. Raymond noted that no sidewalk was required for the Culver's development. Mr. Watson said that sidewalks were required in the JPC area.

Chairman Hatfield noted the length of time since the previous meeting. He said he would like to meet at least once per quarter even if there were no other business. It was noted that there is a need to approve amendments to the JPC zoning ordinance at the same time Rutland Township approves amendments to its zoning ordinance.

It was moved by Mr. Wiswell and seconded by Mr. Jarvis that the meeting be adjourned. Motion carried at 5:52 p.m.
