Hawthorne says that none of that is happening in RCT, even though they have given the ARPA money towards broadband. Jackson says there are more companies that will be involved than what are in the area now.

Jackson says the jail feasibility study is ongoing, the commissioners are discussing body and dash cams and have found that they would be a large expense, the county passed a resolution about keeping employees wages competitive in the market, the COA building construction will begin soon, and the commissioners are working on clean energy ideas.
